## WEDDING RECEPTION/CIVIL CEREMONY

#### **TERMS & CONDITIONS**

- 1. The initial booking shall take the form of a £250 deposit to hold your agreed date until the contract between the customer and Dovecliff Hall Hotel (herein after referred to as DH) has been finalised. The contract will be prepared by DH and sent to the customer for agreement and signature within 14 days. On receipt of the signed contract by DH, the customer shall then pay the remainder of the £1000 deposit. The balance of the deposit should be received by DH no later than 14 days after the contract has been sent to the customer. If terms of the contract cannot be agreed between DH and the customer within 7 days then the initial £250 is refundable. If the customer fails to return the signed contract within 14 days of receipt and subsequently decides not to proceed with the booking, the £250 is non-refundable.
- 2. The agreement is made between both the Bride and Groom irrespective of whom signs the contract form.
- 3. Payments are due and payable as follows -

First deposit is £1000 paid as : -

£250 initial deposit to hold the date pending contract

£750 balance of deposit on receipt of signed contract

Six months prior to the wedding 50% of the final balance will be due.

A final costing will be prepared and due for payment two months prior to the wedding.

The hotel reserves the right to charge 5% interest on late payments. Furthermore, the hotel reserves the right to cancel with no refunds, if payments are not received by the due date or when DH has reason to believe that payments may not be forthcoming.

After the final payment has been made no refunds can be given for any guests who cancel, nor can payments be used towards any other aspect of your wedding.

A 5% discretionary gratuity fee will be added to the total food & beverage charge agreed. We request this be paid in the morning after the event it you are satisfied with the service received. This sum is distributed equally amongst the team. We welcome payments by cash, debit card, Mastercard, Visa, AMEX or BACS.

#### THE HOTEL RECOMMENDS THAT YOU TAKE OUT EVENT INSURANCE.

- 4. Cancellation Policy Any cancellation must be given in writing to DH. All deposits and payments once made are completely non-refundable and non-transferable.
  - The Hotel recommends that you take out Event Insurance.
- 5. Prices quoted and confirmed on the contract are inclusive of VAT. In the event of taxation changes or increased costs beyond the control of DH, we reserve the right to vary prices without prior notice.
- 6. The Contract shows the number of guests attending the wedding for the meal and evening reception this is the minimum number that will be charged for. An increase in numbers may be possible and can be given up to 14 days prior the wedding up to our maximum limit. Payment for any additional guests will be due no later than 14 days prior to the event. The contract includes 15 bedrooms for the night of the event up to a maximum of 30 guests on a bed & breakfast basis.
- 7. Whilst you and your guests are at DH we ask that you make every effort to safeguard the fixtures and fittings. A security deposit of £500 will be held and any damage or losses incurred will be charged for in full. The remainder of the deposit, or full deposit in the case of no damage being incurred, will be returned within 7 days of the event. Offensive, illegal or threatening behaviour may result in individuals or the entire party being asked to leave the premises, in which case no refund will be made. DH cannot accept any liability for loss or for damage to your guests' property.

- 8. DH reserves the right to halt any activity which we believe may cause damage either to the interior or exterior of DH, or is a risk to health and safety.
- 9. DH reserves the right to change the interior or exterior of the building i.e. décor, furnishings, colour scheme without notice. Whilst every effort will be made to ensure that no maintenance work is being carried out on your wedding day, DH reserves the right to carry out such work which is deemed as urgent or necessary.
- 10. Only food and drink purchased from or provided by DH may be consumed on DH premises. This includes alcoholic favours and bottles of wine, champagne or spirits in the bedrooms. DH reserves the right to withhold all or part of the security deposit if DH has reason to believe that food or drink not purchased from the hotel has been consumed by you or your guests.
- 11. DH does not have a corkage facility
- 12. DH has a no naked flame policy.
- 13. DH does not accept any responsibility for the property, i.e. wedding favours, decorations, cards and gifts which are left in DH either prior to or after the wedding. Any property belonging to external suppliers will only be accepted into DH on the day of the wedding and must be removed the following day. DH accepts no responsibility for the safeguarding of such property if not collected.
- 14. We ask that you use only biodegradable or 'bird friendly' confetti. If any other confetti used the Hotel will charge a £75 cleaning fee.
- 15. Any table or room decorations that you would like DH to set out can be set by prior agreement and will incur an additional charge
- 16. Wedding cakes and all fully arranged floral displays should only be delivered on the day of the wedding. Please discuss a suitable time with your Wedding Co-ordinator.
- 17. Exclusive use, if taken, of DH is from 12 noon on the day of the wedding until 11am the following morning. Bedrooms are available from 3pm on the day of the wedding. Additional charges are payable for extra beds in a bedroom and must be by prior arrangement with DH.
- 18. DH reserves the right to cancel the booking if:
  - a) Any part of DH is closed or unavailable because of an event beyond DH control;
  - b) The booking may, in the reasonable opinion of the DH, damage the reputation of the DH;
  - c) either party becomes insolvent

In the event of such a cancellation, DH'S responsibility and liability does not go beyond the level of deposit paid.

19. The hotel reserves the right to vary the terms and conditions and notify them to you at any time.
